

Richard Bowen, a former Business Chief Underwriter for Citigroup, testified publicly before the Financial Crisis Inquiry Commission on April 7, 2010. Mr. Bowen was required to edit out of his written testimony specific evidence of wrongdoing in the Financial Crisis. These actions were described in a September, 2013 article in the *New York Times* "Was this Whistleblower Muzzled?"

On March 20, 2015, Mr. Bowen formally requested that the House Financial Services Committee and the Senate Banking Committee investigate the actions of the FCIC and determine if the evidence he provided was given to the Department of Justice for possible prosecution.
